Terms and Conditions

Minimums and Charges

Hourly Charges: All hourly reservations are charged from garage to garage. The JW Marriott Essex house is considered the garage in Manhattan. There is a minimum 30-minute travel time to and from all pick-up and drop-off locations in Manhattan, with the exception of The JW Marriott Essex House. Travel time outside of NYC varies depending on mileage.

NY State Sales Tax: All reservations that begin AND end in the state of New York are subject to a 8.375% New York State

Additional stops in the course of an airport transfer will incur a \$15.00 per stop fee. If additional stops cause the time to exceed thirty minutes above the cap time (described below), the flat rate will become ineligible and the job will revert to an hourly rate. Otherwise, exceeded time within the thirty minute cap time will be pro rated at the hourly rate.

Cancellations

For pick ups at the Essex House, 60 minutes notice is required to waive any cancellation charge. For pick ups in Manhattan and NY area airports, 2 Hours notice is required to waive any cancellation charge.

Airport Arrivals

For Domestic flights, hotel guests will be met in the baggage claim area. For International flights, hotel guests will be met outside Customs.

Private and Corporate Airports

For both arrivals and departures, we will need to be provided the airport name, name of the Fixed Base Operator (FBO), the lead passengers name, the lead passengers cell phone number (if available), the aircraft tail number and estimated arrival time and reserved departure time.
